Chairman De Pue talked about attending a meeting at Brentsville regarding the current situation and future use of the Williams-Dawe House and passed around a copy of the Community Engagement Questionnaire: The Historic Williams-Dawe House a survey being used to collect input on suggestions regarding the future of the building. Rob Orrison, Office of Historic Preservation, indicated the survey would be provided electronically to members.

Kim Brace passed around a number of articles.

Curtis Porter noted the 32<sup>nd</sup> Manassas African American Heritage Festival of Prince William County is scheduled for Saturday, August 2, 2025, from 11:00 a.m. to 6:00 p.m. at Metz Middle School.

David Peterson reported on attending the Open House at Annaburg Manor.

Marion Dobbins commented on Kathy Kulick's resignation and asked about the election process. Chairman De Pue said the Legislative Committee would address the election process later in the meeting.

David Brickley noted The Society of the Cincinnati House in Washington, D.C. is worth the visit.

Marion Dobbins noted The National Shrine of Saint Elizabeth Ann Seton in Emmitsburg, MD is worth the visit.

### **Staff Time Planning Office**

Justin Patton congratulated Marion Dobbins on her Juneteenth television appearance. Justin reported that as of July 1, 2025, the Planning Office has renamed its three divisions as follows:

The possible boundary expansion for Thoroughfare went to the State Review Board on June 12<sup>th</sup>. No decision has been received. Staff is working on establishing the historic overlay district.

He, Justin, and Calista along with members of the Office of Historic Preservation participated at the well-attended County sponsored Juneteenth event at which a substantial number of historical marker guides were distributed.

Tony Alston, Assistant Planning Director - Countywide Planning, talked about himself and his experience. He commented on what a great team he has and that he's happy to be here at Prince William County.

Calista Nelson, Historical Commission Intern, reported she's done a lot of research including at RELIC, she's narrowing the scope on Ned the Distiller House, and she'd be happy to hear from Commission members.

Commissioner Burgess distributed the following report:

**1. Old Woodbine Baptist Church Marker:**

A representative from the Woodbine Baptist Church (off Dumfries Road in the Coles District) attended the March 2025 meeting to request a historical marker for the original church which is observing its 150<sup>th</sup> anniversary this coming Sunday. John De Pue submitted draft text on behalf of the church which we edited. Our edited text was approved by the church representatives and was included in the May 2025 agenda

packet for Commission review. Further action on this marker is on hold until issues with the church's SUP application can be resolved.

**2. Washington-Reid School Marker:**

Text and funding for a marker at the Washington-Reid Elementary School on Dumfries Road (Route 234), a stop on the county's African American History Trail, was approved in March 2024. The marker has been delivered and awaits installation, which must be coordinated with the School Board.

**3. The Courageous Four Duplicate Marker:**

In September 2024 the commission approved funding (not to exceed \$4,000.) for a duplicate "The Courageous Four" marker requested for the Mary G. Porter Traditional School. Given the backlog at Sewah Studios, the new marker could not be delivered in time for the school's 20<sup>th</sup> anniversary in May 2025. However, a photo reproduction of the original marker was made available for the anniversary.

**4. Approved Proffered Markers Awaiting Fabrication/ Delivery/ Installation:**

It is not known at this time if any of the below proffered markers have actually been ordered.

- Prelude to First Manassas (Orchard Bridge/Blackburns Ford) – Approved August 2022
- Woodbridge School (Riverside Station) – Text approved January 2023
- Old Dominion Speedway Site – Text approved June 2025

**5. Hoadly Marker:**

Text for this marker was approved in August 2020, and it was to be funded by the late Bill Olson whose death derailed the project. Proffered funds may become available to move forward but no new information has been received to date regarding this marker.

**6. Early Land Patents Marker:**

A replacement "Early Land Patents" marker was delivered in 2024. The old site in the Route 1 corridor is currently being developed and a new site has yet to be found.

**7. Prince William County Historical Commission Brochure:**

We noted at the June 2024 meeting that this brochure needs to be updated given that the number of county properties on the National Register, Virginia Landmarks Registry, and County Registered Historic Sites has grown. Amended text to include a list of currently available commission publications has yet to be completed.

**8. Historical Marker Guide Update:**

Copies of the 6<sup>th</sup> edition (2017) Marker Guide are still available, but the supply is getting low. The website version was updated to include the 2017 marker additions but still follows the 5<sup>th</sup> edition (2013) themed format which can be awkward to navigate. The marker guide needs to be



amended with 12 new markers and 4 revised markers. Several others are in the works (see above). Another website update will require the support of the county mapping department and website manager. John McCleary has indicated his support. In the interim, Parks & Recreation have developed a new "Recmapper" App that can be amended to include historical markers. All we need to do is feed them the raw data. Using QR codes is also under consideration.

Legislative

Prince William County Historical Commission Question on 2025 Election of Officers - Commissioner Brickley provided the following:

6/10/25: At the Commission meeting of 6/10/25 Commissioner Blaine Pearsall raised the question as to the proper election of Commissioner Yolanda Green to the office of Vice Chairperson. The Chair, John De Pue, directed that the matter be referred to the Commission's Legislative Committee, which is chaired by David Brickley, with Ernie Porta as a member.

6/10/25: Discussion with Blaine Pearsall. At the conclusion of the regular meeting David and Blaine met at which time Blaine presented his concerns. His concern was that the election was not held fairly. The Nominations Committee had asked for persons interested in running for the position of Chair. Prior to the election on May 13, 2025, two members had expressed an interest in running for the position: Yolanda Green and Eric Brown. As reflected in the approved May 13, 2025, Historical Commission minutes "Nominating Committee Chair (Venessa) Ford provided the slate of officers. John De Pue for Chairman and Yolanda Green and Eric Brown for Vice-Chairman. The Members agreed that the elections would be by voice vote. Members Green and Brown provided comments."

"Elect Yolanda Green Vice-Chairman of the Historical Commission for calendar year 2025. [VOTING RECORD: Green – 11; Brown – 3; Ayes for Green – Brace, Burgess, Davis, De Pue, Dodge, Ford, Green, Kastens, Peterson, Porta, Porter; Ayes for Brown – Brown, Kulick, Pearsall; Nays-None; Absent from Vote None; Abstain None: Absent from meeting Brickley, Dobbins]

"Confirm John De Pue elected as Chairman and Yolanda Green elected as Vice-Chairman of the Historical Commission for calendar year 2025."

"Nominating Committee Chair Ford thanked members and noted that the Committee's job is complete."

In my discussion with Blaine, I noted that the Commission follows Roberts Rules of Order and Blaine agreed that the rules were followed. His concern was that he had been led to believe that Yolanda Green had indicated that she had decided not to run for Vice-Chairman and that based upon that perception, Eric Brown did not present a "campaign speech" to the membership.

6/11/2025: Discussion with Commissioner Vanessa Ford. Vanessa served as chair of the Nominating Committee. She confirmed that the Nominating Committee followed the Commission Bylaws. At the April Commission meeting she read the Bylaws to the Commission members. Two members stated they were running for Vice Chair; Eric Brown and Yolanda Green. There were no other nominees. At the night of the election, she again presented the slate of officers which were Yolanda Green and Eric Brown for Vice Chair. No other nominees from the floor were presented. She then asked each if they would like to make a statement in support of their candidacy. Eric made a short statement followed by Yolanda. There was no further discussion and the votes were taken. Yolanda was elected with 11 votes and Eric received 3 votes. With the election of the Chair and Vice Chair, the work of the Nominating Committee was concluded without objection. Vanessa was confident that the Bylaws were followed.

6/11/2025: Discussion with Dr. Eric Brown. Eric stated that he believed that Commissioner Ford, as chair of the Nominating Committee, performed completely as required. He confirmed that at the May meeting she went over the nominating procedures and stated prior to any votes or discussion that there were two nominees for Vice Chair: Eric Brown and Yolanda Green. He was asked to give his nominating speech first which he did with a short speech, followed by a lengthier speech by Yolanda. The vote was held, and Yolanda was elected Vice Chair by a vote of 11 to 3. It appeared in our conversation that the matter had more to do with a perception on Eric's part based on his understanding of prior telephone conversations with Yolanda on April 8, 2025, and John De Pue on May 5, 2025. According to Eric, in discussions with John and Yolanda he was asked that if he were elected Vice Chair could he attend the meetings in a

timely manner, and could he resolve the matter of caring for his father which had impacted his attendance at meetings. He stated in an email to both John and Yolanda dated May 14, 2025, "You both inquired about my ability to be on time & homecare for my father. I made arrangements to adjust my job hours from 0600-1600 to 0500-1500 on every 2<sup>nd</sup> Tuesday to ensure me being on time and then nurse care for my father was changed from 1100-1600 to 1300-1800 on every 2<sup>nd</sup> Tuesday."

He said that he replied in the affirmative, and in doing so may well have believed that those discussions indicated that he would be Vice Chair with the withdrawal of Yolanda. However, Eric confirmed that at no time did either John De Pue or Yolanda Green state that he would be the only nominee, and that Yolanda would not present herself as a candidate. With this belief, but before any election, Eric notified his County Supervisor that he was going to be the new Vice Chair.

6/12/2025: Discussion with Yolanda Green. Yolanda stated that in approximately March, 2025 she had a conversation with Eric telling him that she was considering not running for Vice Chair but had concerns as to Eric's ability to effectively be Vice Chair and his need to show that he could do the job. He told her that he was changing his work hours and making arrangements for caring for his father. She was not satisfied with those answers as it did not include any discussion as to what he would do as Vice Chair and needed some confirmation that he was ready for the position.

Yolanda stated that despite those concerns she still had not made up her mind on whether to withdraw or stand for election until the actual night of the election. Eric went first in speaking why he should be elected Vice Chair, but she stated that she was disappointed in that he only stated that he would be on time for meetings and had made arrangements to have care for his ill father, but that at no time did he state what his plans would be as Vice Chair for the betterment of the Commission. At that point she decided to stay in the contest and made comments as to her vision for the commission. She said that she was surprised that she won by a vote of 11 to 3.

6/13/2025: Discussion with John De Pue. At the April Historical Commission meeting the nominations for Vice Chair were closed and there were two nominations: Yolanda Green and Eric Brown. On May 5 John talked to Eric expressing his concern about Eric being unable to attend meetings. Eric said that he had resolved his work schedule to make the meetings in a timely fashion. Eric did not mention that he had resolved the matter of his care for his invalid father. John did not tell Eric that Yolanda was dropping out. He confirmed that the actual election of Vice Chair was proper and that both candidates were given an opportunity to speak. He did note that Eric told the commission that he

could make the meetings but did not go into his ideas and vision for the coming year.

No other members were interviewed.

CONCLUSION. There is obviously a clash of visions and views among a number of members of the Historical Commission which has continued for some time. This may go back to the intense Digital Gateway votes which divided the Commission members, or a debate between “East vs. West”, or just a personality clash between committee members.

However, with that being said:

1. There is no question that the Nominations Chair conducted the election fairly and according to our Bylaws and Roberts Rules of Order with the Commission and each candidate being clearly told that there were two nominees for Vice Chair: Eric Brown and Yolanda Green.
2. Although Yolanda in conversations indicated to Eric that she was considering withdrawing her name for election as Vice Chair, she never specifically stated that she was withdrawing her name. This appears to be a misunderstanding on Eric’s part, and the heart of the issue at hand.
3. The Nominations Chair specifically told all before the meeting and immediately before the election that both Yolanda Green and Eric Brown were the nominees. Both Eric and Yolanda were aware that there were two candidates for Vice Chair.

Going back to the founding of our Nation and before up to our current national situation, there have always been disagreements on election results. What should be concerning to the Commission is that this simple election matter has become, in essence, a proxy war among members of the Commission. That has to change.
