Old Business

Governance Representative

- Alicia held an open discussion regarding the dissolution of the DANA committee citing the following reasons:
 - The Governance Committee has not had a committee representative in over a year due to no volunteer.
 - Information discussed is redundant considering many DANA members also attend other committee meetings and HMIS workshops that provide the same information.

- There are several other committees where providers can stay involved and receive HMIS/data information (Service Continuum, CoC At-Large, & PAR).
 - Feedback and thoughts from committee: Several members (T. Golden., M. Tamillow, G. Tibbs, R. Coleman, and A. Ballard) agreed DANA is no longer the best use of time and it should be dissolved. Providers recommend a quarterly spotlight for HMIS/data at the CoC “at-large” committee. The quarterly HMIS workshop will be “revamped” as a one-on-one Technical Assistance session with each participating provider.
