Chair Porter called the meeting to order at 7:30 pm.

**Citizens Time**

- Three citizens were present.

**Old Business**

- The minutes of the February 13, 2025, meeting was approved (Young moved/Johnson – second) unanimously.

**New Business**

- All commissioners believed that the 2025 Universal Human Rights Day Program (UHRD) was a success. Next year, the event will be held on Martin Luther King Jr.’s holiday weekend.
- Resolution to Declare, Affirm, and Recognize the month of March of 2025 as Women’s History Month (Ginoba moved/Johnston second). The resolution passed 7/0.

- A motion was made to adopt Chair Porter's Statement addressing diversity, equity, and inclusion. (Young moved/Ginoba seconded) The motion passed 5/2. The statement was posted to the HRC website and was sent to the local media outlets for publication.
- The Commission agreed to hold preliminary meetings with the PWC Police Department and PWC Schools to address hate/bias incidents that are occurring within Prince William County.

### **Committee Reports**

#### **Unity in the Community**

- Nothing to report.

#### **Jail Board**

- From January to December 2024, the average number of inmates held in the detention center was 571.
- There were 10 transfers of inmates for the month of November, and 11 transfers for December 2024.
- 606 inmates were committed in November, and 619 inmates were committed in December 2024.
- In November, there were 612 inmates released, and 613 inmates were released for the month of December 2024.
- Capt. Allen West was promoted as the next Superintendent of the Adult Detention Center.

#### **Racial Social Justice Committee**

- Nothing to Report.
- The next RSJC meeting will be held on March 20<sup>th</sup> at 6 pm.

#### **Student Leadership Council**

- On January 13<sup>th</sup> the Student Leadership Council held their 3<sup>rd</sup> session. This session was on Fair Housing. Mahalia "Mally" Dryden-Mason was the guest speaker.
- The February session of the SLC will take place on February 20<sup>th</sup> from 4:30 pm to 6 pm at the Kelly Leadership Center. The guest speaker will be Dr. McDade from PWC Public Schools, who will be answering questions from the students as part of the guided discussion.

- On March 13<sup>th</sup>, some of the students will be presenting their human and civil rights essays to the Human Rights Commission.
- Finally, graduation will be held on April 3, 2025, at 6 pm in the Ferlazzo Building Auditorium.

### **Director's Report**

- The Human Rights Office has completed its annual report for FY2024. An electronic copy has been sent to commissioners for your review. A hard copy of the report will be distributed at the next Commission meeting.

This year's theme is African Americans in the Workforce; 100 Black Women in Prince William County will also be hosting their Black History Month event the same weekend and encourage everyone to attend.

**Benjamin Baldwin** – Would like to thank the Chair and Commissioners for being able to disagree with each other and still be able to come together and serve the community.

**Ramunda Young** – Would like to congratulate Chair Porter and Commissioner Pratter for being recognized by the Town of Dumfries for their Services to the Community.

**Evelyn BruMar** – In the Commonwealth of Virginia, Marriage Equality is currently going through the general assembly to be codified to protect same sex marriages; Casa BruMar Foundation is collaborating with law enforcement agencies in Prince William County to conduct Crisis Intervention Training (CIT); Casa BruMar will be conducting a training in the ADC for the Sheriff's department on the services offered by Casa BruMar.
