### Updates

**Strangulation [Domestic] \*ARREST** – On August 5, 2025, the suspect sought in connection to the domestic assault that was reported to have occurred at a residence located in the 13700 block of Keelingwood Cl. in Woodbridge (22191) on June 24, 2024, was arrested. The accused, identified as Demarcus Rashard **WALLEY**, was arrested in Washtenaw County, Michigan.

**Strangulation (Domestic Related) [Previously Released]** – On June 24 at 8:43PM, officers responded to The Crossings at Summerland Apartments located in the 13700 block of Keelingwood Cl. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 25-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck later that day before the parties separated. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Demarcus Rashard **WALLEY**. Attempts to locate the accused have been unsuccessful.

**Strong-Arm Robbery | Assault by Mob \*ARREST/CHARGED** – On August 20, two suspects were charged in connection to the robbery that was reported to have occurred in the area of Silverdale Dr and Lindendale Rd in Woodbridge (22193) on July 30. Following the investigation, the two accused, identified as Pharell Jethro Mafock **KWET** and a **17-year-old male juvenile** were charged. The investigation continues as officers attempt to identify the third suspect involved.

**Strong-Arm Robbery | Aggravated Assault [Previously Released]** – On July 30 at 3:02PM, officers responded to the area of Silverdale Dr and Lindendale Rd in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, was approached by three other male teenagers while he was riding a scooter in the above area. During the encounter, the teens assaulted the victim and initially took his scooter before leaving it at the scene. The suspects left the area in a blue pickup truck. Minor injuries were reported. The suspects were possibly known to the victim.

**Commercial Burglaries \*ARREST** – In August 2025, detectives identified and charged three juveniles in connection to two burglaries that occurred at the Tobacco Time located at 2989 Garber Way in Woodbridge (22192) in late July. During the investigation, detectives determined the same juveniles were connected to other property crime offenses including stolen vehicles. Additional charges related to those cases are pending.

A **15-year-old male juvenile** of Woodridge

Charged with 1 count of **burglary**, 1 count of **grand larceny**, and 1 count of **conspiracy to commit a felony**

**Commercial Burglary [Previously Released]** – On July 29 at 3:06AM, officers on proactive patrol in the area of the Tobacco Time located at 2989 Garber Way in Woodbridge (22192) observed broken glass to the front of the business. The investigation revealed three masked men forced entry had been made into the business using rocks to shatter the front window. A police K-9 searched the business and area for any suspects, no one were located. Various pieces of merchandise were reported missing. No suspect descriptions are available at this time.

**Commercial Burglary [Previously Released]** – On July 25 at 8:11AM, officers responded to the Tobacco Time store located at 2898 Garber Way in Woodbridge (22192) to investigate a burglary. Video surveillance revealed at approximately 3:28AM, two unknown individuals smashed the front window and entered the business. Tobacco and vape products were reported missing.
