

Continuum of Care Program Competition FY16

Funding Announcement

The Department of Housing and Urban Development (HUD) FY 2016 Continuum of Care (COC) Program Funding Process Competition is Now Open. The COC Program (24 CFR part 578) is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, state, and local governments to quickly re-house the homeless while minimizing the trauma and dislocation caused by homelessness; to promote access and to effectively utilize mainstream programs by the homeless; and to optimize self-sufficiency among those experiencing homelessness. The FY 2016 COC Program funding process is administered under the COC Program interim rule and covers the application and award process for FY 2016 COC Program funds. The Prince William Area Continuum of Care has \$527,157 available to support the COC Program priorities as follows: Permanent Supportive Housing (3 projects totaling \$295,271 of \$143,194; \$143,940; \$8,137), HMIS @ \$36,230 (1 project through DSS as the Lead Agency) – Tier 1. Reallocation: \$195,656 (2 projects - \$143,500; \$52,156) for Transitional Housing for DV survivors or Youth 18-24; Rapid Re-Housing and/or Permanent Supportive Housing. All eligible projects will be ranked in two tiers: Tier 1 = 93% of funding \$490,256 - \$36,230 (HMIS) = \$454,026; Tier 2 = 7% of funding \$36,900, Additional funding will be made available for Permanent Supportive Housing Bonus to support Permanent Supportive Housing that will serve chronically homeless individuals/families or Rapid Re-Housing (please contact the Prince William County Department of Social Services -Homeless Services Unit for more details on the Permanent Supportive Housing Bonus). Applications for the FY 2016 COC Program Competition will be made available on July 20, 2016. A How to Apply Workshop will be held for qualifying agencies on Friday, July 22, 2016, in the James J. McCoart Administrative Building, 1 County Complex Court, Prince William VA 22192, in the Cedar Run Room at 1:30pm. Applications for COC Program funding must be submitted to the Prince William County Department of Social Services-Homeless Services Unit on or by 5pm Monday, August 1, 2016.
